

Terms of Use

for the www.kizoa.com web platform

Welcome to Kizoa, the web platform that makes photo sharing easy! Using Kizoa services, not only can you create beautiful slideshows but also store, manage, edit and share your photos online.

Kizoa is a brand owned by the Pixvisio company, registered with the “Registre des Sociétés d’Evry” under the number 490 864 063. Headquarters are located in France, at 3-5 rue Marcel Pagnol, ZI le Clos Auchin, 91800 Boussy St.Antoine.

The following Terms of Use regulate the contractual relationship between all users of the site (referred to hereafter as “you”) and Pixvisio, the company holding the rights to the Kizoa brand.

Pixvisio reserves the right to modify all or part of the Terms of Use, in which case you will be informed of the new Conditions through the Kizoa web platform. Any use of the Kizoa web platform subsequent to modifications will constitute acceptance of the new Terms of Use.

1. Use of Kizoa online services

In order to use Kizoa online services, you must be of legal adult age as defined in your country of residence.

To access Kizoa services, you may be required to provide your gender, first name, last name, email address and any additional information necessary for your registration or use of these services. You are bound to provide information that is true and accurate. The free Kizoa services are intended for private consumer use, and may not be exploited for commercial profit.

2. Functions

Each account you create on the Kizoa platform allows you to form an unlimited number of new groups, and to join an unlimited number of existing groups.

When you create a group, you become its Administrator. You are the sole person allowed to invite members to this group. You may also temporarily or permanently exclude someone from the group if he/she engages in inappropriate behavior.

Since the authorized storage space (1 Go) is linked to each user, in the case where a member leaves the group he/she recovers the photos and slideshows shared in that group but belonging to that member.

All the members of a group have access to the platform's features, including but not limited to:

- the slideshow creation tool

- adding slideshows and albums to your blog
- sending slideshow and album links via email
- photo storage
- the photo-editing workshop
- photo sharing

- downloading of photos in 800x600

3. Rules of conduct

All information, data, text, photos and any other material (referred to hereafter as "Content") whether transmitted publicly or privately, are under the sole responsibility of the person who has sent them. You should make copies of any information files and digital photos before transferring them to the www.kizoa.com site. Pixvisio is in no way responsible for the Content you display, upload or send in any way through the intermediary of the Kizoa platform and website. Pixvisio exercises no control over Content transmitted through Kizoa, and therefore does not guarantee the quality, timeliness or integrity of this Content. Under no circumstances is Pixvisio accountable for the Content itself, errors or omissions in Content, or any loss or damages emanating from the use of Content displayed or transmitted by any means through Kizoa.

Kizoa services may not be used for the following :

- uploading, sending or transmitting by any means any Content that is illegal, damaging, threatening, abusive, libellous, pornographic, vulgar, obscene, hateful, racist, equivalent to harassment or an invasion of privacy, or is reprehensible in any other way;
- activities that are harmful to underage users in any way;
- sending Content that may constitute, among other things, incitement to commit crimes or misdemeanors; propaganda that is racist, hateful or violent toward any race, ethnicity or country; false information; a threat to forces of law and order; information pertaining to the adoption, legal proceedings or suicide of minors or to a private tax situation; libel or insult; an invasion of privacy; any act putting minors at risk, in particular related to the production, transportation and circulation of messages that are violent, pornographic or threatening to human dignity;
- falsifying letter-heads or manipulating identity in any other way in an attempt to conceal the

- origin of Content transmitted via Kizoa;
- uploading, displaying or transmitting by any means Content that violates patents, copyrights, trade secrets, intellectual or any other property rights (hereafter referred to collectively as “Rights”) belonging to others;
- uploading, displaying or transmitting by any means any unsolicited or unauthorized advertising or promotional material (in particular, sending “spam”, junk mail, chain letters or any other form of solicitation);
- hindering or disrupting Kizoa services, servers or networks connected to services, saving or transmitting files or data containing viruses or programs meant to delete data in memory or any other contaminating function, or refusing to conform to the required conditions, procedures, general rules or regulations applicable to networks connected to the services;
- violating, intentionally or not, any law, national or international regulation in effect, or any other rule that has the status of law;
- harassing in any way another or other user(s);
- collecting and storing personal data relating to other users.

Pixvisio cannot preview Content before it is circulated. However, Pixvisio or an individual or entity designated by the company has the right (but not the obligation) to reject or move, at its discretion, any Content available through Kizoa. Pixvisio, or an individual or entity designated by the company, has the right to delete or remove any Content that is in violation of the current terms or is reprehensible in any other way. Any use of Content by the user will be done with the awareness and acceptance of the associated risks pertaining to the appropriateness, usefulness or completeness of this Content.

Although Content is protected, Pixvisio may in some cases divulge Content in order to conform with laws in effect or if, in good faith, Pixvisio esteems it to be necessary (i) in the case of legal proceedings, (ii) to enforce the Conditions of Use, (iii) in response to complaints relative to the violation of the rights of a third party, (iv) to protect the rights or interests of Pixvisio, users of Kizoa, or the general public.

4. Confidentiality of information

In accordance with the French law “Information Technology and Freedom”, the processing of your data has been declared to the National Commission for Information Technology and Liberties (NCIT). The declaration number is 1257631.

Pixvisio is authorized to take, process and use your information. This data is processed using information technology.

You have a permanent right to access and modify any of your personal data, as specified by European texts and national laws currently in effect (article 34 of the law of January 6, 1978). At any time, you may inquire to Kizoa as to what information is held on your subject, and request that this data be modified.

The user’s personal information may be used to inform him/her of Kizoa offers and services, in

particular via email. At any time, you may request to be removed from the distribution list for these messages, by clicking on the specified link which appears at the bottom of each email sent by Kizoa or one of its partners.

Pixvisio does not share your personal information with third parties. Only Pixvisio and its contractual partners may send you information relative to occasional, specific promotional offers. These partners are selectively chosen by Pixvisio and are recognized for the quality of their products and services.

5. Intellectual property

Rights of Pixvisio

All content of the Kizoa website and web platform (also known as the online application), meaning the texts, illustrations and computer code, is the property of Pixvisio. The software program executed in the internet browser is also the property of Pixvisio. Pixvisio grants you the non-exclusive, non-transferable right to use its Software for the sole purpose of employing Kizoa services in the present context, provided that you abstain from (and abstain from allowing any third party to engage in) the following:

- (a) copying, modifying, creating a derivative of, decoding, disassembling or attempting any other means to decrypt the Software's code; and/or
- (b) selling, granting sub-licenses or guarantees for, or otherwise transferring any rights pertaining to the Software.

Any full or partial reproduction of texts, graphics or illustrations, by any process and on any support whatsoever, requires the explicit authorization of Kizoa.

User rights

The photos transferred by the user to his/her account remain his/her property. The user declares that he/she holds, in accordance with the laws currently in effect, the intellectual property rights to the photos he/she stores on the Kizoa web platform according to the Conditions of Use. Kizoa is in no way responsible for the user's violation of any Rights held by third parties that may be committed using the intermediary of Kizoa services.

Responsibilities

The user is aware that he/she connects to the Kizoa web platform and uses its services at his/her own risk. Pixvisio is not responsible for any direct or indirect damages (financial loss, loss of profits..) that a user or third party may suffer for whatever reason in relation to his/her connection to

the site, to the inability to access or connect to the site, or to the site malfunction.
